

To: The First Presidency of The Church of Jesus Christ of Latter-day Saints.

Re: Recent First Presidency message.

August 14, 2021

I was certainly disappointed and disheartened by your recent COVID-19 “get the vaccine” encouragement announcement. It would have been better and safer for many, not to have released it. Each paragraph has an issue of concern. My concerns are that the statements are not accurate and not supported by science. They parrot the language promoted by the CDC, NIH, ‘President’ Biden, many church leaders and politicians. The CDC, NIH and Dr. Fauci have been the source of conflicting true and false information from the beginning: related to masks (they work, they don’t work, wear two or three); vaccines are the only treatment that will save us and stop the pandemic (while there are other known treatments and while it is true that true vaccines are for the prevention of disease the concept that vaccines stop pandemics is not true and never has been; they have said that the vaccines will prevent infection and transmission and then they won’t and don’t; they say that they hope you will have a milder case while the gain of function purpose promotes a harsher inflammatory response; they encourage people who have already had COVID-19 to get the ‘vaccine’ anyway when there are studies that show a long term immune response; they have encouraged pregnant women, young adults and children to get the jab (an experimental biologic gene altering treatment) when there are absolutely no safety studies to promote taking such a risk (encouraging so is irresponsible), etc. They state the vaccines are safe and effective when other data says otherwise. The data recently have shown that many entering the hospitals have already been vaccinated. Just this month the Israel and Massachusetts data showed over 60% were those admitted to the hospital had been vaccinated. This is happening in the UK too. The head of the CDC this month said that we are just a few mutations away from this vaccine being completely ineffective (this will result in the recommendation for vaccine boosters or new vaccines). Dr. Bossche, Yeardon and Fleming have all stated that the ‘vaccine’ is causing the continued spread through this summer and all three have stated that promoting a vaccine during the actual pandemic time forces the virus to try to survive and drives more mutations. They have all said that our current program is unwise and they use valid proven science to back it up.

I will address some of the details below, but wish to state, from my perspective, a problem that members of the church have, and that is idol-leader worship. You know this to be true, so any statement that comes from the office of the First Presidency is often considered a revelation from God, failing to realize that following the brethren is not scriptural, and dangerous to their salvation, as they hand over their agency to others, thus downgrading a great gift of choice that He has given them. President Nelson has correctly recommended that the Saints have their own personal relationship with the Lord through the Holy Ghost. But when a letter like this comes out, I get patients coming in distressed because in their heart they know that they should not get the ‘vaccine’, but now they are confused, because the brethren certainly would know better than they. This happened last year and on the same day of this announcement. Counseling them to make up their own minds or talk to their doctor is not of much help as most doctors just march blindly to those they perceive to be in authority and don’t use their heads and utilize the knowledge they received in school. I consider your generalized statement as being irresponsible and coercive and therefore dangerous to a generally uninformed public. I address the topic of proper informed consent below, which cannot be appropriately performed by anyone as the package insert for the consent contains blank pages. My patients at least do not appear to have actually read these inserts and I suspect that most who take this ‘vaccine’ do not either.

Before I address several topics I would like to say that I am board certified in family practice; was trained in Europe by an Oxford trained immunologist seven days for five years; have taken thirty hours of CME on vaccines; and have studied every week for several hours a night for the last year and a half on the topic of the COVID-19 issue. My conclusion is that there is no good reason to take it and that it is probably very dangerous to do so, especially in relation to long term effects and new exposure events. In my practice I have had patients and those in their families who have had serious adverse reactions, blood clots, strokes, heart attacks, pneumonia and deaths in relation to receiving the 'vaccine'.

There are many doctors from all over the world that are exposing great concerns about this whole issue. I will not list them here other than to just mention three. Dr. Peter McCullough (cardiologist, teacher, Medical Journal contributor), Dr. Richard Fleming (nuclear cardiologist, physicist and research scientist) and Dr. Bosche (former pharmaceutical CEO/research scientist), and there are quite a few others that have spoken out. I point these out because there are three doctors that make up the Quorum of Fifteen, who should know for themselves about some of the issues I address in this letter. Dr. Flemming has stated that he would debate the science with Dr. Fauci anywhere and at any time. Dr. Fauci has not taken him up on this offer, but I would imagine that he would accept such a request from you.

First and foremost, the COVID-19 'vaccine' is not a vaccine. It does not meet the definition of a vaccine. It does meet the definition of a medical device. Last year when I went to Moderna's site they described it as an operating system (not as a vaccine). They use the term vaccine because the population is used to it and are more likely to accept it than if they were told that, if they get the jab they are volunteering to participate in a grand, first of its kind, biological gene therapy treatment program that is entirely experimental and untested in animal studies (successfully) in order for it to be approved by the FDA as being safe and effective.

There is a paper trail that exposes that scientists have been working on a Corona virus vaccine for years, but have not been able to bring one to market because the animals in the studies became horribly ill and died. [As a side note Robert F. Kennedy, Jr.'s Children's Defense site found out that there have not been double blind placebo controlled studies done on the safety of regular vaccines, but compare themselves to the side effect profile of other vaccines as their control group.]

Next, is just to say that COVID-19 was developed as a bio-weapon that focuses on antibody dependent enhancement military research. It originally was worked on here in the States and without going into its history it was transferred to WuHan, China. Dr. Fauci funded it with taxpayer dollars; about 60 million dollars over several years. The recent release of his emails shows that he was complicit with this and has been lying to the American people about its origin and about social distancing and mask efficacy. Even China's Xi Jinping stated this year that they had defeated America with a bio-weapon. The spike protein is man made and manipulated for a purpose. Discussing that would take too much time, but I will at least note that Dr. Martin said that he has patents for the man made viruses going back years, like patent number 727937 in 2002 for SARS. The people involved in the gain of function research have included Dr. Fauci, the Department of Defense, the NIH, and several others. Dr. Fleming actually has a letter inviting him to participate in the research on the virus and for gain of function.

How does this vaccine work? I need to address a couple issues here. First, with the mRNA 'vaccines', they alter the internal machinery of the cell and you begin making the spike protein, which is the

disease that results in endothelial-neural-cardiovascular-tissue damage and inflammation. Your immune system then attacks or responds to this by making antibodies to the N-Terminal domain of the spike protein and when those antibodies attack it opens up the spike protein and makes it much more infective, by 4-10 times. This has never been seen before. This principle although had been discussed in papers going back to the 1990's and 2004. The inflammatory response in the body is caused by T cells dumping their chemicals in the first 3-5 days of infection, followed by the B-cells dumping their chemicals and making antibodies (part of your innate humoral response) on days 7-10. The Salk Institute has also stated that the spike protein causes micro-vascular damage and blood clots. Again this is the result of its gain of function bio-weapon purpose and the 'vaccine' fulfills one purpose by having your body make the spike protein, but it also primes your system for future reactions that can be a more severe reaction when you are re-exposed to the virus or its mutations in the future (this happened in the animal studies). The blood test D-Dimer (elevated with increased risk of blood clots) has been used and noted by doctors to be elevated after receiving 'the jab'.

Warning, warning Bill Robinson. Animal studies have shown that this can cause accumulating damage over time especially to the heart and brain. This can be immediate and continue with insult to tissues or organs over a year later. The scary part would be if a person kept getting the booster 'vaccines'. Studies in Rhesus macaque monkeys showed Lewy body formation (an Alzheimer marker) and in humanized mice models, a spongiform encephalopathy (Mad Cow-prion disease). The 'vaccine' is gene altering involving principles of transfection and reverse transcription. We have no idea what it will cause in the coming years. There is no known off button! This is not something that should be promoted as safe, when the damage it can cause is known, and the long term studies do not exist. One thing I am seeing is persisting fatigue. Dr. Byram Bridle from Canada stated something like: 'we have made a big mistake'. He then went on to say that the Japanese study showed that this 'vaccine' did not just stay in the area of the jab, but ended up in the brain, heart, lungs, liver, spleen, adrenals, testicles and a large amount in the ovaries. From the CDC's own data they say that in general you have less than one percent chance of dying from COVID-19. The elderly have less than a 5% chance of dying. Children are very low risk. So there is absolutely no reason, looking at those percentages to encourage people to get a vaccine that we have been warned by many doctors around the world is very risky to take. And why the children? We are seeing myocarditis, pericarditis, paralysis, reactivation of old viruses, strokes etc. in previously healthy people when their overall risk of death is very low. Since this goes to the testis and ovaries these youth may not be able to have children in the future. This group should especially receive a letter warning them of the danger and not inviting them to take such a risk. The words coming from leaders should not only be well informed, but ideally by revelation. If you have not I would encourage you to do so. With what I know about this I do not see either.

The following is from an article that Dr. Bridle commented in:

"Byram Bridle, a viral immunologist and associate professor at [University of Guelph, Ontario](#) said the medical community "[made a big mistake](#)" [deploying spike protein](#) programs through mass vaccination campaigns. Dr. Bridle was one of the scientists who worked on COVID-19 vaccine development. Dr. Bridle points to a "bio-distribution study" that shows how the spike protein escapes into the blood post-vaccination, and circulates for several days, accumulating in organs and tissues. The spike protein can attack the spleen, bone marrow, the liver, adrenal glands, and in "quite high concentrations" in the ovaries.

"We have known for a long time that the spike protein is a pathogenic protein. It is a toxin. It can cause damage in our body if it gets into circulation," Bridle said. Scientists assumed that the vaccine would only affect the deltoid muscles, reproduce spike proteins in cells at the vaccination site, and elicit an

immune response locally. However, the spike proteins do escape the vaccination site and escape into the blood circulation. These toxins can cause blood to clump or cause brain bleeds.”

It should also be noted here that there are studies that show that those who receive the ‘vaccine’ can also shed it, meaning they can cause disease in others, thus turning the tables on the comments that the un-vaccinated are a danger. The FDA even had papers on this subject of mRNA and DNA gene therapies in 2015 and 2020. There are anecdotal statements on VAERS showing that unvaccinated people in the household get ill after another gets the jab. This is also noted in one of the inserts from one of the pharmaceutical companies that if a couple planned on having children they should avoid contact with each other for seven weeks.

People who are getting the jab are testing positive for COVID-19 afterwards, which would be expected as they are making the spike protein, but they are also getting sick. A recently performed autopsy showed that the spike protein was found in many body tissues.

Speaking of inserts for these experimental emergency use only ‘vaccines’, they fail to adequately provide informed consent to those who receive it as there are several pages that are intentionally left blank. Also, in relation to the research relating to this ‘vaccine’, Dr. Jane Ruby points out that none of Koch’s postulates have been met, this should be a warning to people that this is potentially dangerous. Karen Kingston (a former Pfizer employee and current analyst for the pharmaceutical and medical device industries) revealed documents from Sinopeg (a china company) that among the incipients in the COVID-19 ‘vaccine’ was pegelated lipids, polyethelene glycol and a large amount of graphene (also recently discovered by a European research group). This latter causes an acute inflammatory response but has further implications that I will not present here.

Now, when we have a group of people that are the same people who developed it, funded it, promoted it and are making money off of it and are also producing the pseudo-science political speech surrounding it; we should be very suspicious. In conjunction with the failure to provide informed consent (they can’t), they are also violating: the Biological Weapon Convention Treaty, the Informed Consent-Declaration of Helsinki, International Covenant of Civil-Political Rights and Treaty, and the Nuremberg code. Even doctors are violating their Hippocratic oath who have not read the insert and even if they did, they cannot fulfill the requirement due to the intentional blank pages.

Continuing on this same theme, anyone who mandates the ‘vaccine’ without proper informed consent (which I just stated that they cannot do), is violating not only the international treaties, but also any elected official who is not upholding these treaties and the personal rights guaranteed by the Constitution, are not upholding their oath to protect the Constitution of the United States of America (which is called treason).

VAER’s voluntary reporting data show that there has been twelve thousand deaths and hundreds of thousands of serious adverse reactions related to this ‘vaccine’. Researchers have said that the data placed on VAER’s probably represents only 1% of what is real and that the real number should be 10-100 times more. That would relate to at least 120,000 deaths. Historically, if a drug or vaccine even caused 50 deaths it was withdrawn from the market. The numbers have been further skewed as the CDC has been caught removing data from this voluntary site.

You can't believe the numbers put out by the CDC concerning true cases. A true case includes one who is actually sick. The second issue is that the PCR test was never meant to diagnose (but was used over the last year and a half to do so) but is a laboratory tool. This statement was made by the Nobel Prize recipient, Kari Mullins who created it. The PCR test looks for the presence of genetic code and is best run at 20 cycles. For most of the COVID-19 testing it was run at 35 cycles, so his tool was abused by the CDC. At that level it produces what is called a high noise to signal ratio or resulting in many false positives. The CDC stated recently that they will no longer use this test after December as they consider it inaccurate. It is also interesting that this virus has never been successfully isolated and there is no standard for them to give to labs to do research on. So what are they exactly testing for? The next item to raise suspicion is that flu deaths disappeared for 2020, which means they were blaming everything on COVID-19. Total deaths back at that time were not significantly different than previous years. The University who had performed the analysis soon had their analysis taken down as it did not support the narrative being given to the public.

There are papers that show that there is a T-cell and antibody response to those who get COVID-19 naturally is long lasting. The reason you do not accomplish this with the 'vaccine' is that it gives only one part of the bio-weapon spike protein and thus it is less likely to produce protection to the mutant forms, whereas with a natural infection your immune system is exposed to an envelope component, a nucleic component and a capsid component etc., which confers more protection to future mutant forms, leading to T-cell and antibody measured responses. Also, very important, when you get the infection naturally you are exposed to hundreds of thousands of spike proteins, while you get 13.1 billion with the Pfizer and Moderna, and 50 billion with the Janzen and Astra 'vaccines'. This is not natural.

It should also be noted that mandates are not laws. That is the duty of legislatures. If legislatures allow mandates to be allowed as if they are law, they are failing to uphold their Constitution. Mandates have to do with power, control and violates ones Constitutional rights and freedoms. It's purpose is to take away the agency of the individual, which is given by God. Too many politicians, school boards and church's are violating these rights. What is happening in this country is exactly what took place in Nazi Germany in the 1930's, along with the fulfilling of all Marxist tenants.

There are no studies that strongly support masks. If you are sick they suggest that it may protect others, especially from bacteria. The COVID-19 virus (0.125 microns) is much smaller than the typical mask (filters 8 microns and above) and goes right through. There are studies that show they cause harm by you breathing your own germs (increasing respiratory infections and facial dermatitis), lowering your oxygen levels and raising your CO2, causing depression, loneliness, suicide etc. Reckless un-scientific recommendations can cause great harm without being well thought out. It is especially harmful to little kids for a variety of social and health reasons and they are a group that are low risk. Again, any mandates to have teachers vaccinated increases the risk to the children as you now have a person shedding the spike protein in their presence.

We must awaken to our awful situation, allow people the freedom to choose, to worship, to vaccinate or not, to mask or not, to love your neighbor as yourself, uphold the Constitutional law of the land. They are trying to divide us, among other things. Let us seek to be one with each other and with God. As one person stated: We must stop fighting us. Remember to have courage and be kind, regardless of what personal choice you make. [1 Cor. 3:17, 2 Nephi 4:34; DC 1:19]
